BILATERAL FINANCIAL CONTRIBUTION AGREEMENT

The present bilateral financial contribution agreement is done in the framework of the project 'Anna Kéthly Political School'.

It forms an integral part of the Framework Agreement signed on 01/10/2022.

The present bilateral financial contribution agreement is signed between:

and

Progressive Hungary Foundation Hungary Represented by Mr Ferenc Büttl, Hereafter referred to as "Contributing Organisation"

Article 1 - Duration of the Contract

01/10/2022 - 30/09/2023

Article 2 - Scope of the Agreement

The present contract sets the amount (in EUR) to be paid by the contributing organization to the Foundation for European Progressive Studies and the conditions in which the set amount should be paid.

Article 3 - Legal Framework

All contributions covered by this contract must comply with Regulation (EU, Euratom) N° 1141/2014 of the European Parliament and of the Council of 22 October 2014 on the statute and funding of European political parties and European political foundations, including its subsequent amendments.

Article 4 - Planned contribution

- 4.1. The planned financial contributions by the above-named contributing organization is:
- 5.883,00 EUR in support to the project 'Anna Kéthly Political School'.
- 4.2. The first financial contribution of 2.510,00 EUR shall be received by FEPS the latest by 31/12/2022. The second installment of 3.373,00 EUR shall be transferred to FEPS at the closing of the project.

Article 5 - Budget overview

In relation to the project 'Anna Kéthly Political School' as described and budgeted in the Framework Agreement, the contributing organization is entrusted with:

The budget attributed for these activities by FEPS is 58.826,00 EUR, out of which 5.883,00 EUR are to be covered by the contributing partner in line with Article 4.1.

Any eventual taxes such as VAT are included in the present budget.



The detailed overview of annual budgetary arrangements underlying the present Financial Contribution Agreement is provided as a reference point in "Annex 1 – Budget Breakdown".

Article 6 - Cash flow

Only real cash flow to FEPS is considered as a financial contribution, i.e. when the contributing organization wires the financial contribution to the FEPS account. Direct payments in the framework of a project expense, or contributions in kind such as, but not limited to, working time, in-kind sponsorship, do not represent financial contributions in the scope of this agreement.

For the purpose of facilitating the implementation of the activity, no local budget is foreseen.

Shall local expenses occur, FEPS will only assess their eligibility upon the submission of:

- A formal invoice.
- A financial table with the overview of the costs
- Supporting documents for all incurred costs (numbered in relation to the financial table with costs' overview), which are to be official invoices, issued by suppliers to the contributing organization, with a specific mention of project 'Anna Kéthly Political School'. If original documents are not provided in French or English language, a brief description of the rendered service (e.g. "translation", "proofreading", "catering", etc.), as well as the title of project 'Anna Kéthly Political School' are to be included in English on the official invoices.

Article 7 - Communication

7.1. Any change to the present financial contribution agreement shall be requested ex-ante in writing to the FEPS contact point included in chapter IV of the Framework Agreement and agreed in writing within a delay of 10 working days, upon consultation with the FEPS legal representative

7.2. Written documents shall be sent to FEPS' Brussels office: Foundation for European Progressive Studies Avenue des Arts 46 1000 Brussels Belgium

Article 8 - Termination of the Agreement

8.1. Specific reasons (not restrictive) justifying the termination of the contract on part of FEPS without any kind of compensation and without any delay:

Shall local expenses occur, FEPS will only assess their eligibility upon the submission of:

- The preconditions, for entering into the contract cease to exist after the fact;
- The contract has been entered into on the basis of information which was substantially incorrect or incomplete
- The contributing organization has been dissolved, in course of proceedings or does not present anymore financial viability as required
- 8.2. Any cost associated with the termination of the financial contribution agreement or damages suffered by breach of the present contract, shall be borne by the contributing organization consistent with the principle of their responsibility.

Article 9 - Legal Actions - Law and Jurisdiction

- 9.1. FEPS reserves the right to take any legal action against the contributing organization in the event of a breach of any provision of the present financial contribution agreement. Belgian law shall apply to the present financial contribution agreement. Belgium shall be the place of jurisdiction.
- 9.2. In the event of a breach of its obligations, and provided that irreparable damage has not already been caused, FEPS may give to the contributing organization to comply with its obligations. In the event that the formal notice by email remains without effect 15 days after its receipt, FEPS reserves the right to terminate the contract without being liable for any compensation, and without any kind of obligation.

Article 10 - General provisions

- 10.1. The failure of either party to seek performance of one or more of the provisions of this contract shall in no event be construed as a waiver of the application of such provisions
- 10.2. Any additional agreements exceeding the scope of this financial agreement must be agreed by both parties in writing in order to be valid
- 10.3. Time periods refer to working days
- 10.4. When changing bank account details, the project partners are required to formally notify FEPS and send the new financial bank account number and identification



10.5. If specific provisions of this agreement should be declared legally invalid, this shall not affect the validity of the remaining provisions of the agreement.
